AN APPROXIMATE ECONOMIC VALUE FOR THIS VOLUNTEER TIME CONTRIBUTED FOR THE STATE OF ILLINOIS IS \$34.29 AND \$33.76 PER HOUR USING THE MOST RECENT DATA RELEASED BY THE U.S. BUREAU OF LABOR STATISTICS FOR 2025 AND 2024, RESPECTIVELY. APPLYING THIS RATE, THE ORGANIZATION'S COMMUNITY VOLUNTEER SERVICES WOULD BE VALUED AT \$1,290,196 FOR 2025 AND \$1,452,558 FOR 2024. INCLUDING THE ECONOMIC VALUE OF DONATED COMMUNITY SERVICES AS PART OF PROGRAM EXPENSES WOULD RESULT IN THE CALCULATION OF PROGRAM EXPENSES AS 81% AND 80% OF TOTAL ORGANIZATION EXPENSES AND SUPPORT SERVICES AS 19% AND 20% FOR 2025 AND 2024, RESPECTIVELY. PROGRAM SERVICES AS A PERCENTAGE OF TOTAL ORGANIZATION EXPENSES IN THE AUDITED FINANCIAL STATEMENTS ARE 37% AND 34%, FOR 2025 AND 2024, RESPECTIVELY. SUPPORT SERVICES AS A PERCENTAGE OF TOTAL ORGANIZATION EXPENSES IN THE AUDITED FINANCIAL STATEMENTS ARE 63% AND 66% FOR 2025 AND 2024, RESPECTIVELY.
